


# Care Plus Program: An Expedited Care Coordination Program for High Utilizers



## Virtual Client Record

Pulls data points from various County databases to create the Golden Record, a one-stop for Client information.



## Aggregate Population Data and Reporting

Queries data points about an individual to provide better insight about trends, needs, and service gaps for targeted populations.

Identifies characteristics of High Utilizers for Multi-Disciplinary Team and enhanced care coordination.



## Multi-Disciplinary Team (MDT)

A collaboration tool that pulls all stakeholders who can effect change into one room to coordinate care for an individual.







- Individual has been booked 4 or more times in the last year (12-month cycle)

## Cohort Goals

- Reduce Recidivism
- Ensure continuity of care throughout the Corrections System of Care (successful re-entry to community)
- Develop an MDT approach centered on stakeholder integration, collaboration, and sharing of information to effectively coordinate care for Corrections High Utilizers

---

## Care Coordination Principles

- Increased efficiency and effectiveness to expedite linkages to services
- Continuity of care to achieve care coordination goals
- Transition planning between intake, reentry and community (re-entry upon entry)





MENTAL ILLNESS	82% M / 87% F
SUBSTANCE USE DISORDER	43% M / 50% F
CO-OCCURRING	42% M / 50% F
Increased diagnoses in Transitional Age Youth (age 18-20 years) population:	
MENTAL ILLNESS	68% M / 96% F
SUBSTANCE USE DISORDER	57% M / 72% F
