

In Custody

Stabilizing individuals and work towards successful reentry upon entry into the jails

Completed:

- Remodeled the intake area to add more privacy
- Increased MH beds in-custody
- Added CIT Training to the Jail Academy curriculum
- Increased CHS staffing to address increased MH needs
- Established an in-custody drug treatment program
- Increased and enhanced MH therapeutic groups provided
- Established specialized housing with programming
- MAT treatment services

To Be Completed:

- Remodel of the step-down care units
- Develop staffing and programming plan for Musick
- Specialized Housing for females who are veterans
- Develop and implement an educational & vocational program focused on achieving certifications
- Case Management
- Data/Metrics

Reentry

Continue Reentry programs started while in custody and provide services/linkages and resources to help all justice involved individuals reintegrate back into their communities

Completed:

- Established a process to keep or expedite public assistance benefits
- Established a Workforce Solutions Center near Theo Lacy Facility

To Be Completed:

- Establish regionally located reentry service centers and transportation services
- Modify the existing YGC to serve as the Coordinated Reentry Center
- Establish a workforce training center, ideally with a retail component
- Develop and implement an informational campaign targeting cities, local law enforcement as well as individuals involved in the criminal justice system and their families
- Data/Metrics

Juvenile & TAY

Seeking to establish programs, services, and resources to prevent youth from entering the juvenile justice system, helping them while they are detained, and provide a continuum of services to help them succeed

Completed:

- Established the first Adolescent CSU at the Be Well North Campus
- Added Crossover Youth Court
- Implemented Virtual Training Program
- Obtained SUD residential treatment beds for females 12-17 years old

To Be Completed:

- Develop and implement a plan to collaborate with schools to address awareness, diversion and interventions
- Ensure youth programming at Be Well South
- Coordination of Remediation Services for detained youth
- Establish new Youth Transition Center
- Establish TAY Transitional Housing
- Data/Metrics

- Presentations & Updates will continue






Programs and Reentry Unit


Back on Track Program
