- I. Call to Order/Introductions/Opening Remarks: Meeting called to order by OCCJCC Co-Chair Supervisor Doug Chaffee. Opening remarks emphasized the importance of awareness concerning the community corrections system of care and each department's responsibility and efforts to ensure that as shifts are made during implementation, the efforts of other departments or stakeholders are not negatively impacted.
- **II. Review and Approval of Minutes:** Meeting Minutes of March 17, 2023, were approved. The motion was made by Supervisor Doug Chaffee and seconded by Public Defender Martin Schwarz. Approved unanimously.
- III. Navigating Housing Options & Eligibility: A presentation was made by Doug Becht, Office of Care Coordination, on the various types of housing from low barrier through permanent supportive housing that included the number of available units, target populations, eligibility requirements, and information on how to access.
- **IV. Juvenile/TAY Prevention Discussion**: A presentation was made by Mark Lawrenz, Health Care Agency, and co-chair of the Juvenile/TAY Prevention Task Force. The presentation shared the efforts of the task force, points of engagement identified, listing of resources, and areas of focus and next steps planned.

V. OC CARES Funding and Project Updates:

a. Communication Strategy:

CEO provided an update on engaging a Public Relations Firm to assist with consistent, targeted messaging and to attract individuals for employment in this area.

b. <u>Jail Releases Outside of Business Hours</u>:

CEO responded to the service issues identified at the prior OCCJCC meeting in March and shared progress made to acquire contracted services to address the afterhour needs.

c. Quarterly Report:

CEO shared the 2025 Vision Quarterly Report for the period of January to March 2023 noting some items anticipated to be completed by the end of the fiscal year were delayed. Project updates were provided by the following:

- Collaborative Court Expansion: The Courts provided a brief update on the status including the progress on securing a location and addressing current needs.
- James A. Musick Jail Facility: OCSD shared factors that have caused the planning opening of the facility to be delayed to October or early November and believe any additional costs incurred can be covered by their planned contingency.
- Mobile Reentry: Probation Probation informed the committee that the pilot was delayed due to supply issues and that Probation was awarded a related grant that will also provide \$2M to procure up to 2 RV vehicles to establish a robust mobile program.
- VI. OCCJCC Comments: There were no Council Comments.
