2. Update on Bridges at Kraemer Place shelter operations by Mercy House
MERCY HOUSE CHIEF PROGRAM OFFICER TIMOTHY HUYNH PRESENTED AN UPDATE ON CURRENT SHELTER OPERATIONS AND METRICS, INCLUDING STATISTICAL UPDATES FOR PROGRAM EXITS, RE-ENTRIES, LONG-TERM AND TRANSITIONAL HOUSING. FROM JULY 1, 2021 THROUGH MAY 31, 2022 (CURRENT YEAR), 528 INDIVIDUALS WERE SERVED, COMPARED TO 491 INDIVIDUALS SERVED THE PREVIOUS YEAR. THE CURRENT YEAR SAW 378 INDIVIDUALS EXIT THE SHELTER COMPARED WITH 359 THE PREVIOUS YEAR. OF THE 378 EXITS, 42 INDIVIDUALS EXITED TO PERMANENT HOUSING. THE MOST SIGNIFICANT CHALLENGE TO EXITING TO PERMANENT HOUSING IS FINDING APPROPRIATE UNITS. THE AVERAGE LENGTH OF STAY AT THE SHELTER IS 125 DAYS.
