SB 918 Implementation Overview

Prior to SB 918, California had no stated goals related youth homelessness. The bill mandates that the state:

 <u>Set measurable goals</u> (outcome measures) to prevent and end homelessness among California's youth.

*New measures to be tracked and reported at the community level (CoC and county) in alignment with current CA SPMs

CA System Performance Measures

Series of metrics that help the state and local jurisdictions assess their progress toward preventing and ending homelessness.

Modeled after federal (HUD) measures covering housing and income. ("Adult Centered")

Calculated based upon data entered into HMIS at the local level; therefore, an incomplete picture particularly in communities where HMIS use is lower.

Project Goals

Overall Goal for 2024:

 Gather data and establish goals to prevent and end homelessness among youth and young adults across CA

Goals for 2025 & 2026:

- Develop outcome measures to track progress towards these goals
- Develop tools and resources to assist communities in implementing developed data collection processes related to the outcome measures
- Provide technical assistance and training to communities for conducting
 trauma informed data collection and improving coordination between systems

Purpose of Stakeholder Engagement Sessions

Beyond <u>current</u> data collection and reporting requirements (i.e., CA SPMs), to determine which additional youth-specific, community-level measures should be implemented across the state.

Should the existing SPMs be supplemented in any way with new youth-centered measures around housing outcomes?

Should new non-housing measures be implemented?

Purpose Cont'd

We want to discuss these questions within the context of what is viable, considering the barriers to implementation for HMIS lead agencies, service providers and program participants.

We also want to discuss this in the context of feedback we have heard through recent focus groups involving youth and young adults with lived experience.

The sheltered count took place on the night of Monday, January 22, 2024, and the unsheltered count occurred between Tuesday, January 23, 2024, through January 25, 2024.
