Grant Terms

Communities will have 6 months to submit a coordinated community plan, if/when announced as awarded

U.S Department of Housing and Urban Development (HUD) Program-Specific Goals and Objectives

- The YHDP application should align with the following highlighted goals outlined in HUD's Strategic Plan:
 - Goal 1: Support Undeserved Communities
 - Fortify support for underserved communities and support equitable community development for all people.
 - Goal 1B: Reduce Homelessness
 - Strengthen Federal, State, Tribal, and community implementation of the Housing First approach to reducing the prevalence of homelessness, with the ultimate goal of ending homelessness.
 - Prevent and End Youth Homelessness
 - Build national momentum
 - Promote equity in the delivery and outcomes of homeless assistance
 - Highlight the importance of youth leadership
 - Evaluate the coordinated community approach
 - Expand capacity
 - Evaluate performance measures
 - Establish a framework for Federal program and Technical Assistance (TA) provider collaboration

Eligible Program Participants

Funds awarded under the YHDP must only be used to serve:

- Youth, a person who is age 24 or younger who initially qualify as homeless under paragraph (1) or (2) of the homeless definition in 24 CFR 578.3 or section 103(b) of the McKinney-Vento Homeless Assistance Act
 - Unaccompanied Youth persons who are age 24 or younger, who is the only member of the household.
 - Pregnant or Parenting Youth Individual heads of households who are age 24 or younger who are pregnant or who are the parents or legal guardians of one or more children who are present with or sleeping in the same place as that youth parent.
 - Transition Age Youth- persons between age 18 and 24.
- Youth who initially qualify to be served as stated in I.C.5 of Appendix A of the YHDP Notice of Funding Opportunity (NOFO)

Changes from Previous NOFO



Communities that have received an FY2016 or FY2017 YHDP community designation are eligible to apply for and receive an additional YHDP community designation under this NOFO.



The minimum number of youth required to be on a Youth Action Board is **increased** from three to **four** members.



Additional Special YHDP Activities are identified in Appendix A.



Appendix B is updated to reflect a new process for developing and submitting the Coordinated Community Plan (CCP) for HUD approval, including a phased approach to CCP submission and approval, as well as the addition of a requirement to complete and submit a Continuous Quality Improvement Plan (CQI) after the first year of project operation.

Community Need – 25 Points

Collaboration – 20 Points

Youth Collaboration – 20 Points

Data and Evaluation Capacity – 15 Points

Total: 100 Points

Youth Action Board (YAB) Integration 20 Points HUD will award up to 20 points to applicants that demonstrate that the CoC actively engages potential YAB members, ensures that YAB members represent a diverse range of backgrounds and that the YAB is fully integrated and prioritized in the CoC.

Community Need 25 Points

HUD will award up to 25 points to applicants that can demonstrate high need in the community based on the number and needs of the community's youth experiencing homelessness.

Collaboration 20 Points

HUD will award up to 20 points to applicants that can demonstrate **strong current community-wide partnerships** that are working to prevent and end youth homeless

Youth Collaboration 20 Points

HUD will award up to 20 points to applicants that demonstrate how voices of youth with lived experience of homelessness are a crucial component to addressing and ending youth homelessness.

In order to receive points under this rating factor, applicants must attach a communication of support for the application from the YAB. This communication may be in written, audio, or video format.

HUD will award up to 15 points to applicants that can demonstrate the community is effectively using data and project performance to assess and improve its youth homelessness response system.

Orange County Youth Action Board Planning

- Eligible Applicants for YHDP project funding (Project Applicants) are required to have a YAB and must receive the approval of the YAB for their project(s) through a letter of support.
- As shared in the YHDP NOFO, HUD will award up to 20 points to applicants that demonstrate that the CoC actively engages potential YAB members, ensures that YAB members represent a diverse range of backgrounds and that the YAB is fully integrated and prioritized in the CoC.
- At this time, there is recommendation to approve an establishment of a YAB to be recommended to the CoC Board for approval, to ensure that the YAB is fully integrated under the Orange County CoC.

Orange County 2024 Point In Time Count (PIT Count)

- The County of Orange in partnership with the Orange County CoC conducted the sheltered count the night of Monday, January 22, 2024. The unsheltered count process took place over three days, Tuesday, January 23, 2024, through January 25, 2024.
- The 2024 PIT Count identified a total 308 Transitional Aged Youth (TAY) of ages 18 to 24.

Comparison of Orange County 2022 and 2024 PIT Count

• In comparison to the 2022 PIT Count, the TAY subpopulation increased by 31.06% in the 2024 PIT Count.





Orange County 2024 Housing Inventory Count


- The Housing Inventory Count (HIC) is a point-in-time inventory of housing programs within a CoC that provide beds and units dedicated to serve people experiencing homelessness, or for permanent housing projects, that serve people experiencing homelessness as defined by HUD.
- The HIC occurs on the same night as the Point-in-Time Count (PIT). The total for Orange County's 2024 HIC is 9,812 beds, which was a 189 bed decrease from 2023.



Orange County 2024 Housing Inventory Count

• In the 2024 HIC for the Orange County CoC, 138 beds out of 9,812 beds were specifically allocated to youth. 1.40% of all project beds in the Orange County CoC are youth dedicated beds.





Orange County 2024 Housing Inventory Count

- Orange County United Way as the HMIS Lead, identified that an increase in bed inventory is needed for youth beds and other special populations to align with the unhoused population according to the 2024 PIT.
- Approximately 255 more youth beds are needed to address the gap and align with the 2024 PIT Population.

First Youth Homelessness Systems Improvement (YHSI) Grant Awardees Announced

- On June 6, 2024, HUD announced the award of \$51.1 million in it's first ever YHSI Grant to 38
 Communities across 26 states. Puerto Rico and Guam have been awarded the first of its kind grant.
- The goal of YHSI grants is to create a more seamless and coordinated system of care for youth experiencing or at risk of homelessness. These grants aim to improve the identification of youth in need and make it easier for them to navigate available services.
- Though the Orange County CoC was not awarded YHSI funding, the Orange County CoC plans to continue applying for future opportunities to serve more youth experiencing homelessness or at risk of homelessness.

Homeless Housing, Assistance and Prevention (HHAP) Program Round 6

- HHAP Round 6 has been included in the final budget deal of the FY2024-25 Governor's Budget.
- \$1 billion in one-time assistance will provide local governments funding to combat the homelessness crisis tied to increased accountability measures.
- A reimagined accountability unit will monitor the HHAP plans cities and counties submit and will ensure cooperation between various groups.
- The Office of Care Coordination will continue to provide updates as they arise.
