Melanie Martins shared that the U.S. Department of Veterans Affairs (VA) is adopting a
one team approach, where all organizations and systems work together to reduce barriers
for veterans. This includes working with community partners and public housing

- authorities to quickly house veterans and address any barriers that arise. The goal is to create universal applications and processes that can be used throughout Orange County.
- Santa Bob provided an update on Project Home Key, specifically the Costa Mesa motel conversion, Mesa Vista. As of today, the first twelve residents are all veterans.

### **BUSINESS CALENDAR**

- 1. Veterans Committee Reorientation and Vision Setting Becks Heyhoe, Chair, and Sarah Jones, CoC Manager, Office of Care Coordination

Chair Becks Heyhoe reviewed governance charter of both the Veterans Committee and CoC Board. Chair Becks Heyhoe reviewed the CoC leadership vision and objectives. The CoC has led the collaborative effort to build and sustain a fluid system to prevent homelessness and quickly intervene with solutions to end homelessness among veterans, transitional aged youth (TAY), and families, while making significant, measurable progress for all populations experiencing homelessness.

# **Public Comments:**

 Jaime Caraballo shared that there is a gap between public homeless services and that of veteran specific services. Jaime Caraballo asked if there can be a representative on the CoC board that can connect the board to veteran services and help bridge that gap.

# **Committee Discussion:**

- Melanie Martins shared the importance of having this committee bring back to the efforts of the CoC to their respective organizations.
- Chair Becks Heyhoe asked if it would it be helpful to facilitate some trainings out of this committee around the CoC and Coordinated Entry System (CES) as it pertains to veterans?
- Melanie Martins shared that it would be helpful to know about resources within the CoC that are not veteran specific to be able to share with the committee's respective organizations.
- Melanie Martins expressed the concern around senior veterans that are at risk of being homeless and the barriers that are preventing them from qualifying for services.
- Chair Becks Heyhoe shared about the importance of having a veteran specific dashboard to share information on progress to ending veteran homelessness and floated the idea that more may need to be incorporated than is shown on the current veteran CES

- dashboard for example Permanent Supportive Housing (PSH) projects with veteran priority vacancies.
- Chair Becks Heyhoe spoke about the importance of collaboration with the housing authorities and the work of the CoC Housing Opportunities Committee.
- Chair Becks Heyhoe went over the seat vacancies on the committee: Orange County housing providers or Public Housing Authorities and Health care agency that serves veterans at risk of or experiencing homelessness.
- Jade Smith shared how she is no longer with Tierney Center and shared how she now works in mental health. Jade asked if she should represent a health care agency seat.
- **2.** Targeted Outreach for Veterans Update Michael Ruiz, Program Manager, Supportive Services for Veteran Families (SSVF) OC, Volunteers of America

Melanie Martins gave an overview of target outreach for veterans. The VA developed the Veterans Collaborative Outreach Team with community partners to enhance their ability to quickly reach and provide services to unsheltered homeless Veterans in their area. Members of the team conduct weekly outreach together.

## Committee Discussion:

• Chair Becks Heyhoe shared information on City Net's unsheltered survey and suggested this survey information be provided to the committee.

# 3. Continuum of Care (CoC) Update – Sarah Jones, CoC Manager

a. Veteran Registry Data

Sarah Jones presented an update on the Veterans Registry Data. Currently, there are 232 veterans on the Veteran Registry. In the previous 12 months, 205 veterans have been housed in permanent, stable housing. Over 30 agencies including the VA Community Resource and Referral Center., outreach providers, and shelter providers, continue to meet weekly to coordinate housing and services for veterans experiencing homelessness in Orange County. In the past 12 months, there has been a 1% decrease in the number of veterans experiencing homelessness in Orange County.

#### b. 2024 Point In Time Count

Sarah Jones shared an overview of the 2024 Point In Time Count. Over 1,100 volunteers provided more than 4,000 hours of service for the Point In Time Count. Volunteers assembled over 6,000 hygiene kits and snack packs. The Office of Care Coordination expects the results in early May. Additional identifying information was collected for unsheltered veterans encountered. The Point in Time Count updates the Veteran Registry and provides a follow-up tool for street outreach teams. Volunteers of America

was provided survey data collected during the Point in Time Count of all those surveyed who stated they were a veteran to coordinate targeting and outreach to unsheltered veterans.

# **Committee Discussion:**

- Chair Becks Heyhoe noted a discrepancy on the chart. The chart had 232 Homeless veterans on the Veteran Registry, but in the month prior, there was 268. If there were 268 the month prior, and the inflow for January was 17, with the outflow 17, it does not equal 232. Chair Becks Heyhoe asked for some clarification.
- Sarah Jones will inquire about this discrepancy with Coordinated Entry System (CES) team.
- 4. Provider Announcements and Feedback Becks Heyhoe, Chair
  - a. Providers and members of the public are invited to share announcements and feedback related to Veteran homelessness.
- A member if the public shared that PATH has obtained a contract with the city of Newport Beach to do outreach. They have already placed six (6) individuals with temporary and permanent housing.

- **1. 2024 Orange County Point In Time Count** Sarah Jones, CoC Manager, Office of Care Coordination
  - a. Overview of Veteran data presented in the Orange County 2024 Point In Time Data Summary.

Sarah Jones presented on the data from the 2024 Orange County Point In Time Count. During the unsheltered PIT Count, those surveyed who identified as having served in the U.S. Armed Forces, National Guard or Reserves (Veterans) were asked for additional identifying information to ensure follow up and further connection to services. For further coordination of targeting and outreaching to unsheltered Veterans, Volunteers of America, Los Angeles (VOALA) staff were provided survey data collected during the 2024 PIT Count of all those surveyed who stated being a Veteran. VOALA staff then made efforts to engage and provide connections to services. ### Public Comments:

• Michael Ruiz shared that it would be helpful for future PIT Count efforts to be aware of known encampments of individuals experiencing homelessness.

# **Committee Discussion:**

- Eric Richardson shared that the funding around COVID-19 relief played a large part in the decrease of numbers in the 20222 PIT Count. Eric Richardson recommended that at the next PIT Count volunteers receive improved training to collect more accurate data and record the specific location of each individual.
- Melanie Martins noted that there are differences between the PIT Count data and the By Names List (BNL) regarding Veterans. Melanie Martins suggested capturing specific data to be able to identify subpopulations within veterans.
- Chair Becks Heyhoe asked if City Net can provide a geolocation to VOALA to outreach
  to identified veterans. Chair Becks Heyhoe announced that OCUW will be hosting a
  virtual community chat on June 6, 2024 regarding the Orange County 2024 Point In
  Time Count.
- **2.** Targeted Outreach for Veterans Update Eric Richardson, Director for Housing, and Amanda Brear, Regional Program Manager, Volunteers of America Los Angeles

Eric Richardson presented the following data from the BNL:

- 183 veterans experiencing homelessness, including
  - o 22 unsheltered
  - o 61 sheltered or at-risk of homelessness
- 125 Veterans with a Disability
- 119 enrolled in Veterans Affairs Supportive Housing (VASH)
- 122 enrolled in Supportive Services for Veteran Families (SSVF)

Eric Richardson noted there have been collaborative efforts between the VA, SSVF, County contracted Regional Care Coordination Services, and street outreach teams, inclusive of case conferencing meetings occurring every two weeks focused on the three veteran subpopulations. During targeted outreach, that the following services have been provided are shelter or hotel, extra support while in temporary accommodation, extra support towards finding housing, and ongoing support if temporary accommodation is not accepted.

Eric Richardson presented updates on the subpopulations for Veterans:

- 20 total veterans whose length of homelessness has been longer than ten (10) years
- 94 total Older Adult veterans (ages 62 and older)
- 23 total veteran Families with minor children (households with at least one minor child and one adult)

## **Public Comment:**

 Marisol Johnson inquired about details relating to the Housing and Disability Advocacy Program (HDAP).

## Committee Discussion:

- Melanie Martins shared that the BNL helps the VA to connect to other agencies and build relationships. Melanie Martins shared the importance of working together with different agencies to access different resources.
- 3. Orange County Outreach Services Mapping Update Becks Heyhoe, Chair
  - a. Update on Orange County United Way's United to End Homelessness efforts to map available outreach services in Orange County

Chair Becks Heyhoe presented on OCUW's research on available outreach services in Orange County, detailing known outreach providers for each city and region.

## Committee Discussion:

- Melanie Martins inquired about the services provided by the HOPE Center.
- Eric Richardson announced the opening of the Central Cities Navigation Center.
- Larry Smith inquired if cities with no assigned outreach team have access to Coordinated Entry System (CES) through street outreach services.
- 4. Veterans Committee and Orange County Veterans and Military Families Collaborative (OCVMFC) Housing Working Group Collaboration and Alignment Discussion Becks Heyhoe, Chair, and Eric Richardson, Director for Housing, Volunteers of America Los Angeles and OCVMFC Housing Working Group Chair
  - a. Discuss ideas for further collaboration and alignment between the Veterans Committee and the OCVMFC Housing Working Group

Chair Becks Heyhoe and Eric Richardson led a discussion around future collaboration between the Veterans Committee and the OCVMFC's Housing Working Group to discuss potential collaboration and alignment of efforts.

- Melanie Martins shared on the importance of having all stakeholders present for meetings.
- Larry Smith emphasized the importance of different groups being presented in order to collaborate well toward a common goal.
- **5. HUD-Veterans Affairs Supportive Housing (HUD-VASH) Voucher Update** Sarah Jones, CoC Manager, Office of Care Coordination

Sarah Jones presented on the current metrics for the HUD-VASH vouchers available in Orange County.

- Chair Becks Heyhoe stressed the significance of regularly bringing data related to the status of HUD-VASH vouchers in Orange County to the Veterans Committee.
- Larry Smith shared that it would be beneficial for the Public Housing Authorities to have a document specialist that can assist veterans to prepare documentation needed for the process of applying for a HUD-VASH voucher.
- **6. Continuum of Care (CoC) Update** Sarah Jones, CoC Manager, Office of Care Coordination
  - a. Veteran Registry Data

Sarah Jones presented the following CoC updates:

- Veteran Registry Data Currently, there are 183 veterans experiencing homelessness
  on the Veteran Registry. In the previous 12 months, 207 veterans have been housed
  in permanent, stable housing. Over 30 agencies, including the VA Community
  Resource and Referral Center, outreach providers, and shelter providers, continue to
  meet weekly to coordinate housing and services for veterans experiencing
  homelessness in Orange County. In the past 12 months, there has been a 24%
  decrease in the number of veterans experiencing homelessness in Orange County.
- Coordinator for Coordinated Entry System (CES) for Survivors Request for Proposals (RFP) The County of Orange's Office of Care Coordination is requesting proposals from qualified organizations to act as the Coordinator for the CES for Survivors in Orange County's North, Central, and South Service Planning Areas (SPA). The selected organization will facilitate regional service coordination, ensure compliance with CES requirements, and implement strategic efforts to enhance access to housing resources. Additionally, the selected organization will support the implementation of diversion and solution-focused strategies to reduce homelessness and optimize housing resource utilization. Programs should be quickly operationalized and able to leverage additional funds to expand their impact.
- 2024 VAWA and Survivor Housing Community Conversations The U.S. Department of Housing and Urban Development (HUD) is hosting a series of community conversations focused on successfully implementing the Violence Against Women Act (VAWA) and survivor-centered housing at the system, project, and human levels. Each conversation will feature a diverse panel of system leaders, project staff, and people with lived experiences from both the homelessness response and victim services worlds.
