MINUTES ____ September 19, 2024

Melanie Martins motioned to approve Item 1 on the Consent Calendar. Jeffrey Pagano seconded the motion. Chair Becks Heyhoe, Larry Smith, Jeffrey Pagano, Ruby Lara and Melanie Martins voted "yes". Motion passed.

Sarah Jones presented updates on the Orange County 2024 Point in Time (PIT) count data and the Coordinated Entry System (CES) Veteran Registry data.

Public Comments

 A member of the public inquired about the number of individuals experiencing homelessness who are still actively serving in the military and not included in the Veterans' resources.

Committee Discussion

- Melanie Martins highlighted the higher rates in trauma and mental health conditions among Veterans, particularly affecting the older adult population in Orange County. Melanie Martins stated that homelessness of women Veterans is on the rise. Melanie Martins shared that many Veterans remain in Orange County after being discharged, raising questions about the impact of military service time on homelessness. Melanie Martins shared that there is a need to support National Guard members as well and provide resources for those unable to access Veterans services.
- Chair Becks Heyhoe-Khalil highlighted a significant disparity between general population
 PIT count data and Veteran PIT count data related to physical disabilities, particularly in
 relation to Veterans living with HIV/AIDS. Chair Becks Heyhoe-Khalil noted that data on
 older adult Veterans shows higher rates of health conditions, and there is a substantial
 difference in the prevalence of these conditions between genders.
- Jeffery Pagano shared various potential reasons for the high rate of Veterans with disabilities found in the PIT count data.
- Larry "Smitty" Smith inquired about reasoning for the 2024 PIT Count survey having two
 separate questions for people who served in the National Guard versus people who are
 active military members. Larry "Smitty" Smith expressed that there should not be a
 division between the two and proposed consideration for questions being combined in
 future PIT counts.

Ruby Lara presented on changes related to the HUD-VASH income eligibility requirements.
