- **Hate-motivated incidents, Community Conflict, & Crisis Response/Meetings**

- Commission staff reported victims were robbed at gun point after offenders' dog pit the victim, in Huntington Beach.
- Commission staff reported the victims' home was broken into, religious belongings were vandalized, and other personal belongings were destroyed or stolen, in Irvine.
- Commission staff reported a victim, in San Diego, was called the n-word at work. The victim quit after a month and now the offender is using social media to harass him and others.

#### HATE CRIMES VS. HATE INCIDENTS




Out of the 17 hate-motivated events, **seven hate crime**, **five hate incident**, and five unknown were reported


#### SENTIMENT
