



# Hate activity increased in 2018 for O.C.


• 37% increase in hate incidents from last year

Steady rise in hate activity in the last 5 years


## 10 YEAR TREND FOR HATE CRIMES & HATE INCIDENTS IN O.C.




#### **2018** Hate Crime vs. Hate Incident - Motivations
