# SUMMARY ACTION MINUTES

## PUBLIC COMMENT

Ken Baer – Was looking at the current membership roster and noticed there is a vacancy for the Lived Experience Representative and would like to be considered for the seat; previously experienced homelessness in Orange County; has achieved a bachelor’s degree from UCLA and has been focused on addressing homelessness and homeless service delivery; believes he can provide insightful contributions to the Commission.

## COMMISSION MEMBERS COMMENTS

Commissioner Hurst – Recently learned his seat is coming up for renewal; provided insight into church partnerships and stated he believes churches are the unsung heroes in combating homelessness; thanked the Commission for the opportunity to serve and believes the right people are at the table and great things can happen in addressing homelessness.

### 2. Commission to Address Homelessness Update

#### a. Bylaw Revision Updates

**Commission Director Doug Becht presented an update on the bylaw revisions, which were approved by the Board of Supervisors during the February 25, 2025, meeting.**

#### b. Membership Ad Hoc

**A new Membership Ad Hoc has been established to recruit members in accordance with the new bylaws; Commissioners provided insights and suggestions in the recruitment and application process.**

#### c. 2024 Commission Ad Hoc

**Commission Director Doug Becht recognized all the great work of the Ad Hoc Committees, and many have now closed as their work has been completed.**

### 3. Office of Care Coordination Update

#### a. 2025 Orange County Supportive Housing NOFA

**Orange County Community Resources (OCCR) released the 2025 Orange County Supportive Housing Notice of Funding Availability (2025 NOFA) which includes over \$12 million of Federal Home Investment Partnership American Rescue Act Plan Program (HOME-ARP) funds, Mental Health Services Act funds, and 150 housing choice, mainstream or VASH (Veterans Affairs Supportive Housing) project-based vouchers. OCCR incorporated in the 2025 NOFA that small-scale housing unit proposals will be considered, provided the criteria and the guiding principles of the Small-Scale Housing Unit Report are met.**

- b. 2025 Homeless Survey  
**Office of Care Coordination, working with City Net, completed the 2025 Homeless Survey; 840 surveys were collected, and the Office of Care Coordination hopes to bring results of the 2025 Homeless Survey to the Commission this summer.**
  - c. OC Same Day Solutions Fair  
**On March 27, 2025, the Office of Care Coordination hosted the first OC Same Day Solutions Fair at the Second Baptist Church in Santa Ana; representatives from various County agencies, state government agencies, non-profits, community organizations, vendors, and volunteers provided services and resources; the District Attorney and Public Defender assisted in dismissing charges and/or clearing warrants on minor offenses related to homelessness that can hinder the ability to obtain stable housing; each person on average received between two to three services; the Office of Care Coordination hopes to host another event, possibly in South County or North County; Chairman Sarmiento thanked Pastor Pitts for making his church available, not just for this event but for many community events and services.**
4. Commissioner Spotlight – Commissioner Adam Hawley, Chief of Police, Brea  
**Commissioner Hawley highlighted the Hope Center, which was launched as a collaborative effort in which law enforcement entities throughout North Orange County provide meaningful homelessness outreach and engagement; eight out of twelve cities have onboarded to the Hope Center which include Stanton, Cypress, La Palma, Buena Park, Fullerton, La Habra, Placentia, and Brea; last year the Hope Center saw almost 8,000 calls and 4,500 client engagements; the Hope Center is currently funded through 2027.**

### PRESENTATIONS

5. Federal Legislative Update presented by Peter DeMarco, Director of Legislative Affairs, County Executive Office and Cori Takkinen, Townsend Public Affairs, Inc.  
**Presentation provided information on the impacts to federal funding resulting from various executive orders, including significant layoffs to the U.S. Department of Housing and Urban Development (HUD) made by the Department of Government Efficiency (DOGE); a number of housing programs, grants and regulatory actions are being impacted; the Homelessness Fraud and Corruption Task Force (Task Force) was recently created by newly appointed U.S. Attorney Bill Essayli; the Task Force will investigate crimes related to the misappropriation of funding allocated towards the eradication of homelessness in the Central District of California, as well as fraud schemes involving the theft of private donations intended to support services for homeless populations.**

## OFFICE OF CARE COORDINATION UPDATE

### 2025 Orange County Supportive Housing Notice of Funds Availability

Orange County Housing and Community Development (OCHCD) released the 2025 Supportive Housing Notice of Funds Availability (NOFA) which makes available up to \$12.05 million of Federal HOME Investment Partnerships (HOME), HOME American Rescue Plan Program (HOME-ARP), Mental Health Services Act (MHSA), 15G Reserves and Housing Successor Agency (HSA) funds to promote the acquisition, new construction, and acquisition/rehabilitation of Supportive Housing and will also provide up to 150 Housing Choice, Mainstream, and/or Veterans Affairs Supportive Housing Project Based Vouchers (PBVs) for extremely low-income households who are experiencing homelessness.

Small-Scale Housing Units (SSHUs) are considered an eligible activity under the NOFA so long as the criteria and the guiding principles in the Commission to Address Homelessness SSHU Report are met.

# DISCUSSION – ITEM #3

## OFFICE OF CARE COORDINATION UPDATE

### 2025 Homeless Survey

The aim of the 2025 Homeless Survey is to explore the complex issues facing people who are experiencing homelessness for the first time, including what services and programs they may have accessed or attempted to access in efforts to remain housed, and the challenges they have faced as a result of unsheltered homelessness. The findings of the survey will be used to support with future planning and program development, as well as decision-making efforts specific to homeless prevention.

- The Office of Care Coordination worked closely with City Net to consolidate the feedback received from the Commission to Address Homelessness, the Continuum of Care Board, and the Lived Experience Advisory Committee into the survey.
- City Net completed the data collection phase of the survey throughout the month of March and has begun initial analysis.
- The Office of Care Coordination will be facilitating another Joint Special Meeting of the Commission to Address Homelessness and the Continuum of Care Board to discuss the findings.

# DISCUSSION – ITEM #3

## OFFICE OF CARE COORDINATION UPDATE

### OC Same Day Solutions Fair

The Office of Care Coordination engaged County departments, local jurisdictions and non-profits to coordinate the first ever OC Same Day Solutions Fair.

This collaborative effort provided immediate on-site support to individuals experiencing homelessness by offering a range of services such as legal and document assistance, healthcare, housing resources, workforce development, and expanded access to Homeless Court.

Representatives from the OC Social Services Agency, OC Health Care Agency, OC Child Support Services, OC Public Defender, OC District Attorney, OC Community Resources, OC Probation, Department of Motor Vehicles, Revival Hair, Salvation Army, OC United Way/2-1-1 and more were in attendance.

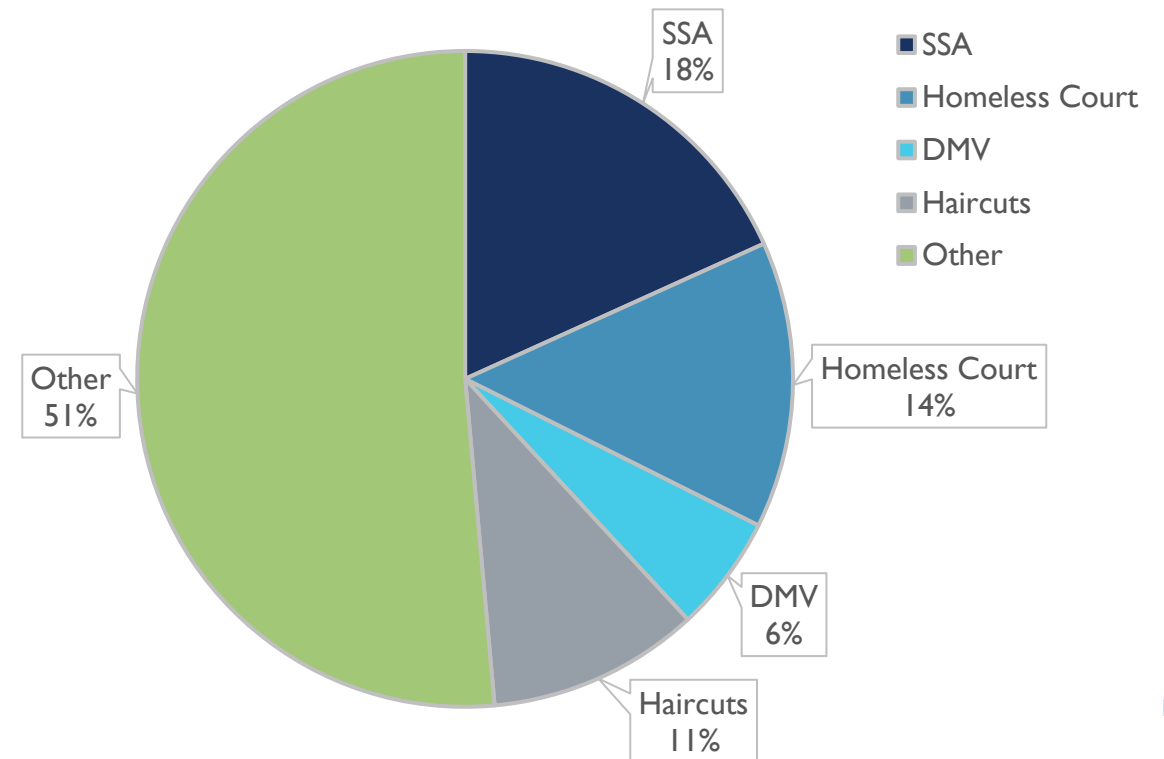

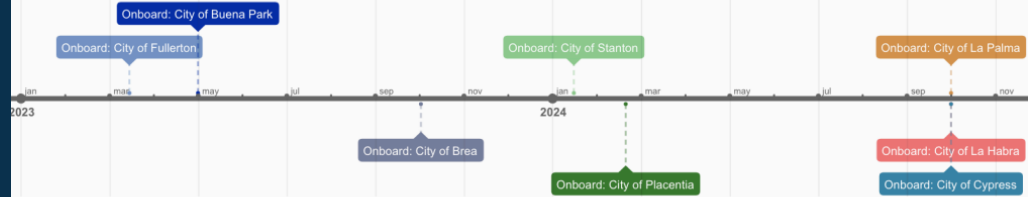
- **Mission:**

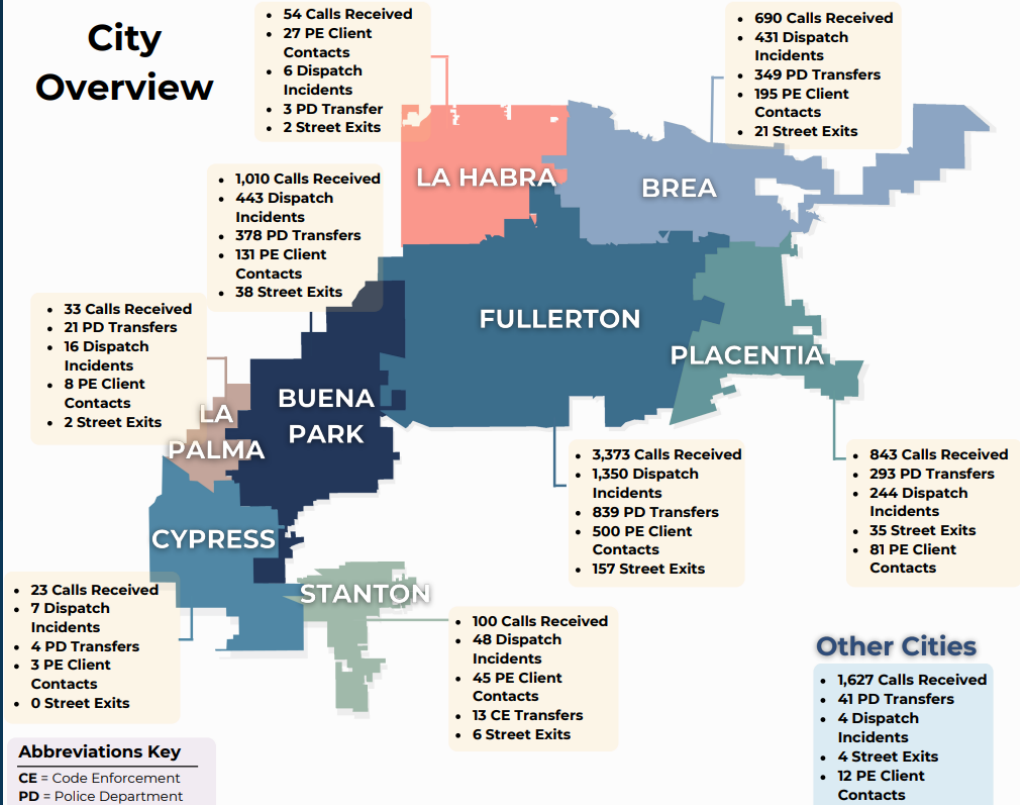
## ANNUAL DISPATCH OPERATION SUMMARY

Maintain consistent Project Homekey, Homeless Housing, Assistance and Prevention (HHAP) and other program funding streams to support the provision of services to the unhoused. Expedite and expand the provision of funding for affordable housing construction to support priority populations, such as veterans, those with behavioral health needs, and those experiencing homelessness.

#### Workforce & Affordable Housing

Seek legislative actions to increase Orange County's ability to meet its housing planning obligations, including flexibility for meeting RHNA requirements. Request regional disbursement of LA fire housing recovery funds to include Orange County, along with critical regulatory reforms, to expedite rebuilding and construction of new workforce housing.

#### Fire Insurance Availability

Seek legislative actions that review & update building hardening measures for property-level and community-wide wildfire mitigation. Advocate for modernizing the framework insurance companies use to evaluate community hardening and fire resilience and reduces the cost of fire insurance. Seek legislative actions that increase California FAIR Plan liquidity & claims-paying capacity.



Maintain the priority listing of the Southern California Veterans Cemetery on the Department of Veterans Affairs Priority List of State and Tribal Governments Cemetery Construction Grant Pre-Applications. Provide expeditious approval, review, or input, as needed, to ensure the Southern California Veterans Cemetery progresses.

**Beach Preservation & Coastal Funding**  
Request funding for County coastal protection, including sand replenishment and improvements to the San Gabriel River Flood Control Channel.
