## **Participation Opportunity: CoC Nominating Ad Hoc**

Each year, the CoC Board appoints a CoC Nominating Ad Hoc tasked with overseeing the nomination and selection process for new CoC Board members and recommending updates to the nomination and selection process in the CoC Governance Charter. Currently, this includes activities such as interviewing eligible candidates seeking CoC Board seats and determining which candidates go to the full CoC Board General Membership for voting and election.

The Office of Care Coordination is reaching out to invite you to consider participating in our CoC Nominating Ad Hoc. Here are some important things to note if you are considering being a member of the ad hoc:

- <u>Total number of people</u>: The ad hoc include at minimum six (6) members:
  - At least one (1) member will be a CoC Board member whose seat is not up for election;
  - At least one (1) member will be a Voting General Member or represent an organization that has a Voting General Member;

- At least four (4) members will not be current CoC Board members
- <u>Time commitment</u>: The ad hoc will meet up to five (5) hours biweekly as needed. Please note, this may increase with the ad hoc members' consent during the CoC Board election and interview process.
- <u>Dates of time commitment</u>: The time commitment for the ad hoc will be from September through December 2025 (estimated)
- Meeting type: The Ad Hoc meetings will be held virtually.
- Please note, all ad hoc members will also be asked to complete a Conflict-of-Interest Disclosure and Statement form.
