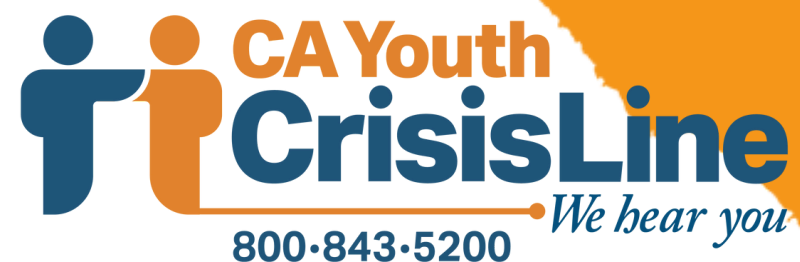

FY2025 CoC Program NOFO Planning: Executive Directors Meeting

- In preparation for the anticipated FY 2025 CoC Program NOFO, inclusive of major changes as reported by [Politico](#), the Office of Care Coordination as the Collaborative Applicant, convened the executive directors of the CoC-funded agencies on Friday, October 10, 2025.
- While each agency and project uniquely serves households of varying degrees of vulnerability, a **shared goal** emerged focused on using the CoC Program funding and resources **to keep people housed and prevent households from returning to homelessness**.

Business Calendar – Item #3

FY 2025 CoC Program NOFO Planning: Individual Meetings with Agencies

- Following the meeting with Executive Directors, the Office of Care Coordination (OCC) requested CoC-funded agencies complete an impact analysis for each renewal project.
- Information received provides OCC as the Collaborative Applicant with more detailed information on the specific activities being funded under each grant, current households being served, considerations for compliance with other funding sources leveraged, and whether agencies are discussing willingness to comply with language seen in the CoC Builds funding opportunity and Executive Orders.
- OCC scheduled individual meetings with each agency to review analyses submitted, gather additional data, and better understand the potential impact to service provision and operations at the project-level.
- The information and data collected will support with OCC completing an overall analysis of renewal projects and prepare a contingency plan, dependent on what is seen in the FY 2025 CoC Program NOFO.

Federal Legislation Updates

U.S. Government Shutdown Updates

The U.S. government shutdown has now entered its 37th day as of November 6, 2025, the longest shutdown in American history. The Senate has failed to pass a funding bill, and critical services are being disrupted nationwide.

- **Supplemental Nutrition Assistance Program (SNAP)**
 - ❖ Food assistance funding expired on November 3, 2025, and the Trump Administrative has committed \$4.65 billion in partial payments for November SNAP benefits but it may take months to reach recipients.
 - ❖ Those receiving CalFresh benefits can call 2-1-1 or visit 211oc.org for assistance or visit local food banks for emergency food and nutrition support.
- **Runaway and Homeless Youth Act (RHYA)**
 - ❖ Beginning on September 27, 2025, some RHYA applicants received notice that their new 2025 RHYA grants were awarded.
 - ❖ If you have not heard anything about your 2025 RHYA grant application, then your announcement could be delayed due to the government shut down. You can check in with your federal program officer, but keep in mind that they may be placed on temporary leave due to the government shut down.

One of 4 initiatives at OCUW, United to End Homelessness is committed to ending homelessness in Orange County so that everyone has a place to call home.

U2EH's Work with TAY

- Since 2019, partnered with local Public Housing Authorities, Social Services and Orangewood to house FYI and FUP voucher holders through WelcomeHomeOC, housing 182 unique households with a 96% retention rate.
- Funded a pilot Youth Action Board.
- Community lead for the Youth Homelessness System Improvement Program (YHSI) application on behalf of our CoC.
- Community lead for the Youth Homelessness Demonstration Program (YHDP) application on behalf of our CoC.
- Summer 2025, piloted a Youth Homelessness Prevention and Diversion Program with Orangewood, Covenant House and Project Hope Alliance.

- Policies and Procedures- Created + Submitted to County
- Participant Handbook Created + Submitted to County
- 10/1/2025 - OCUW assumed responsibility for compensation
- All LEAC Members have been onboarded and received first payment

Compensation Options

Prepaid Debit Card

- One (1) business day to process
- Reloadable
- Does not require bank account
- Can be used anonymously
- Can be used everywhere Debit Mastercard is accepted, including ATMs

- Transferrable to bank, PayPal, or CashApp

Direct Deposit

- 1-3 business days to process
- Requires bank account
- Best for those **not receiving benefits**

- One (1) business day to process
- Reloadable
- Limited spending, specific stores
 - Gas, groceries, Amazon, Walmart, etc.
- **Best for those receiving benefits**

Gift Card

- If mailed, 7-10 business days to process
- If picked up, 1-6 business days
- Requires bank account
- Best for those **not receiving benefits**

Currently, there are **223** households in the TAY subpopulation that are enrolled in a CES program. Of those households, there are only **135** TAY households that have had their Housing Interests assessed and are on the Community Queue.

There are **69** TAY households experiencing chronic homelessness, which decreased by **1** from August.

115 TAY households report having a disabling condition, and **102** households are experiencing mental health conditions.

Homeless Housing, Assistance and Prevention (HHAP) Request for Proposals (RFP) Update

- On August 28, 2025, County of Orange’s Office of Care Coordination released the RFP for Services Coordination, Permanent Housing Delivery, and Prevention and Shelter Diversion Services, to support the programming of HHAP Rounds 3 and 4 funding.
- The RFP closed on October 2, 2025.
- In total, there were 14 agencies that responded to the RFP. The number of proposals received by program type are included below.
 - ❖ Program A: 8 proposals
 - Program A (TAY): 3 proposals
 - ❖ Program B: 6 proposals
 - Program B (TAY): 0 proposals
 - ❖ Program C: 7 proposals
- Interview and consensus meetings began the week of October 27, 2025, and have extended through the week of November 3, 2025.
- Depending on the evaluation process, the Office of Care Coordination will prioritize bringing a portion of the HHAP funding recommendations to the November CoC Board meeting or provide a full slate of recommendations at the December CoC Board meeting.

HHAP Round 5 Recommendations

- At the October 22, 2025, meeting of the CoC Board, the CoC Board approved HHAP Round 5 recommendations.
- The following recommendations were approved as it relates to youth:
 - Approve the issuance of an RFP to solicit for RRH Programs that utilize a short-term (up to 3 months) or medium-term (4 to 24 months) models to award the remaining \$773,200.01 under the RRH eligible use category and \$434,991.06 under the RRH Youth Set-Aside eligible use category, to prioritize serving youth (ages 18 to 24) and older adults (ages 62 and older). The RFP will prioritize current CoC-funded agencies whose funding is at jeopardy.
 - Approve the award and contracting of \$2,448,862.73 of HHAP Round 5 funding allocated to the Orange County CoC under the Operating Subsidies Interim Housing and Operating Subsidies Interim Housing Youth Set-Aside eligible use categories to sustain current CoC-funded emergency shelter projects and other key projects serving people experiencing as detailed below:
 - a. \$500,000 for Emergency Shelter Operations and Services for TAY with Covenant House California to be expended by June 30, 2026.

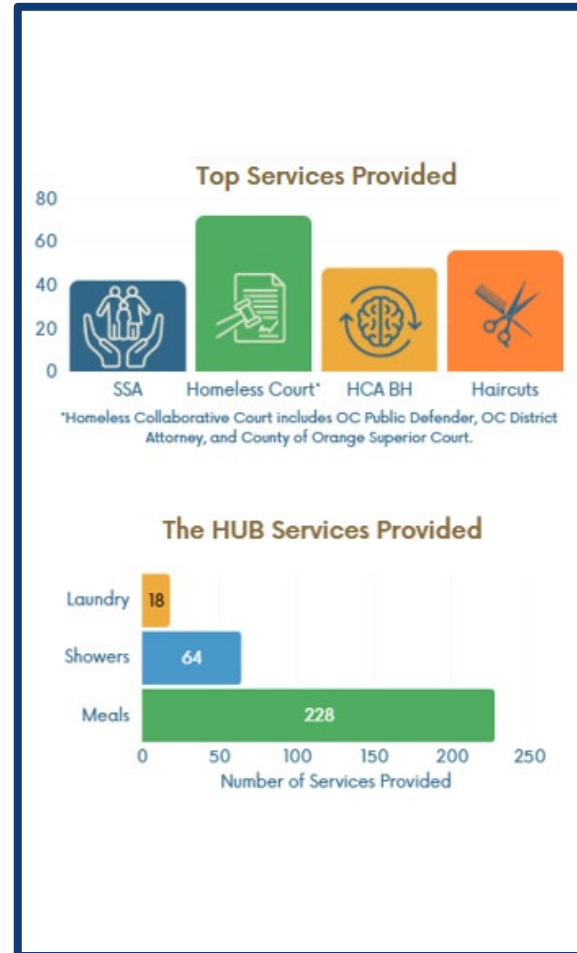
CES Policies and Procedures

- At the October 22, 2025, meeting of the CoC Board, the CoC Board approved the following revisions to the CES Policies and Procedures:
 - ❖ Removal of shelter status from the prioritization schema
 - ❖ Explaining CES prioritization in depth
 - ❖ Additional clarification on how Access Points can indicate the target populations they serve
 - ❖ Defining Open and Closed Access Points
 - ❖ Clarifying language on grievance procedures and dynamic matches
 - ❖ More information on emergency transfers due to concerns relating to domestic and other violence

- The Office of Care Coordination hosted its third OC Same-Day Solutions Fair at The HUB Resource Center on September 25, 2025.
 - 236 Unduplicated Households Participated
 - 664 Total Services Provided
 - 310 Services Provided by The HUB Resource Center
- The next OC Same-Day Solutions Fair is scheduled for November 20, 2025, in Placentia in partnership with HIS-OC.

2026 Point in Time (PIT) Count

- HUD requires that CoCs across the nation complete a biennial unsheltered count and an annual sheltered count of all people experiencing homelessness in the community on a single point in time during the last 10 days of January.
- The Office of Care Coordination in partnership with the Orange County CoC conducts an unsheltered Point In Time count every two years in Orange County.
- In August 2025, the Office of Care Coordination met with City Net, the lead agency for unsheltered count, to plan for the 2026 PIT Count.
- The Office of Care Coordination has also started facilitating recruitment for the PIT Count Planning Ad Hoc, with meetings set to begin in early September.
- Details for the 2026 PIT Count are being finalized and further updates will be provided in the future.

- The 2025 CoC Nominating Ad Hoc confirmed prioritizing the following identities and experiences, as reflected in a previous CoC Governance Charter:
 - (1) Black
 - (2) Indigenous or Native American
 - (3) Person of Color (including but not limited to people who are: Asian, Asian-American, Pacific Islander, Native Hawaiian, Latino/a/e/x, Central American, South American, Caribbean, Middle Eastern, North African)
 - (4) LGBTQIA+, including at least one (1) person who identifies as LGBTQIA+ based on each of the below categories:
 - a. Sexual orientation: Lesbian, gay, bi, queer+
 - b. Gender identity: Trans, non-binary, intersex, non-conforming+
 - (5) Disabled and/or neurodivergent
 - (6) Veteran/military service experience or part of a veteran/military service family
 - (7) Experience of domestic violence/intimate partner violence
 - (8) Older adult

National Summit on Youth Homelessness and Hill Day

- This fall, the National Network for Youth's webinars on the [criminalization of youth homelessness](#) and [supporting young parent families](#) offered a glimpse into conversations that are often missing from national discussions. National Network for Youth highlighted youth homelessness service providers, shared innovative solutions, and, most importantly, centered the voices of youth experiencing homelessness, including young parents.
