COMMISSION MEMBERS COMMENTS

Chair Sarmiento – Welcomed new Commissioners, Benjamin Vazquez and Ivan Pitts; Commissioners were also invited to attend the 2nd District's Small Scale Housing Summit on November 5, 2025, at 9:30 a.m.

Commissioner Hurst – Wanted to take a moment to thank Commissioners whose term ended and recognize their service on the Commission and the impact on the work to address homelessness.

DISCUSSION ITEMS

- 1. Commission to Address Homelessness Update
 - a. Membership Update

Commission Director Doug Becht reported that the Board of Supervisors approved the appointment recommendations to the Commission to Address Homelessness and thanked Commissioners Monique Davis and Lisa Kim for their time and contribution to the Commission.

b. Joint-Special Meeting with the Orange County Continuum of Care Board

A joint-special meeting with the Continuum of Care Board was held on September 10, 2025, to present findings of the 2025 survey titled, Falling Through the Safety Net: Understanding Individuals' Journey and Contributing Factors to Homelessness; feedback received will be included in the final report.

- 2. Office of Care Coordination Update
 - a. OC Same Day Solutions Fair

Commission Director Doug Becht announced the success of the third OC Same-Day Solutions Fair hosted in the City of Orange on September 25, 2025; including 236 attendees and 664 total services provided; the next OC Same-Day Solutions Fair is scheduled for November 20, 2025, in the City of Placentia in partnership with HIS-OC; and thanked the Commissioners for their support and involvement.

b. State Action for Facilitation on Encampments (SAFE) Task Force

Commission Director Doug Becht discussed Governor Newsom's August 29, 2025, announcement of SAFE Task Force, which prioritizes and deploys California's comprehensive network of services to remove encampments on state rights-of-way in California's ten largest cities, including the City of Anaheim; the SAFE Task Force, which includes CalTrans, CalOES, and CHP, worked together with the Office of Care Coordination

and City of Anaheim to clear encampments and connect individuals with resources including access to shelter beds.

On the motion of Commissioner Spitzer, seconded by Vice Chair Cunningham, the Commission directed the Chair and the Office of Care Coordination to request Board of Supervisors' approval for the Commission to send a letter to the SAFE Task Force to communicate concerns and make suggestions for collaboration to achieve common goals.

c. 2026 Point in Time Count

The 2026 Point in Time Count will take place over three days starting on January 27, 2026 (Central Service Planning Area), January 28, 2026 (North Service Planning Area) and January 29, 2026 (South Service Planning Area).

d. Request for Proposals

The Office of Care Coordination released two Requests for Proposal (RFPs), first for Services Coordination, Permanent Housing Delivery and Prevention and Shelter Diversion Services and second for County Emergency Shelter Operations & Services.

3. Commissioner Spotlight – Commissioner Robert Morse, Continuum of Care Board Representative

Commissioner "Santa Bob" Morse presented a video detailing his story including what led him to experience homelessness, his journey out of homelessness and his determination not to leave others experiencing homelessness behind; his determination has led to his work and involvement in several forums to advocate for those experiencing homelessness.

PRESENTATIONS

4. Homelessness Legislative Impacts and Advocacy Strategy by An Tran, Director, Orange County Social Services Agency; Julia Bidwell, Director, Orange County Housing and Community Development; and Douglas Becht, Director of the Office of Care Coordination.

Director of the Orange County Social Services Agency, An Tran, presented on anticipated impacts of HR-1 to Medi-Cal/Medicaid and Cal Fresh/SNAP programs including elimination of automatic renewals, a new requirement for recertification every six months and updated requirements to participate in work activities as a condition of eligibility for those ages 19 – 64; HR-1 did not include funding for additional resources to address the resulting increased workload for program staff.

Director of Orange County Housing and Community Development, Julia Bidwell, discussed impacts of the Emergency Housing Vouchers Program ending earlier than anticipated and plans to transition a portion of the impacted households to Housing Choice Vouchers this year, and the remaining 389 households will gradually transition to the Housing Choice Voucher through July 2028.

Commission Director Doug Becht provided an update on legislative impacts to the Continuum of Care (CoC) Program and changes to the U.S. Department of Housing and Urban Development (HUD) guidelines to limit funding for permanent housing to 30% of CoC funding, instead of the current 87%.

On the motion of Commissioner Peinemann, seconded by Commissioner Rios Faust, the Commission recommended that:

Due to expected changes, many individuals who were formerly homeless and are currently housed through the Homeless Service System, including the CoC Program and federal rental assistance, are at risk of re-entering homelessness. As such, the Commission, the CoC Board, Cities and County departments collective priority should be to prevent their homelessness and must collaborate to identify and secure alternative funding, programs, and services to support their long-term permanent housing stability.

As such, the Commission recommends that the Office of Care Coordination submit a memo to the Board of Supervisors stating the Commission's concerns related to the CoC Program and federal rental assistance that is at risk and recommending that the Board direct County Departments to prioritize the prevention of these households entering homelessness by developing recommendations for alternative funding, programs, and services to support long term housing stability to bring back to the Board.

 - iii. Nathaniel Shinagawa, Senior Vice President and Chief Operating Officer of UCI Health, as the Hospital Representative with expertise in the local hospital emergency room treatment and discharge system
 - iv. Maricela Rios-Faust, Chief Executive Officer of Human Options, as the Continuum of Care Board Representative
 - v. Robert Morse, Homeless Advocate, as the Continuum of Care Board Representative

- vi. Virgil Asuncion, Commander of Southwest Operations Division, as the Orange County Sheriff-Coroner Department Representative in a leadership and/or command level role with knowledge of the Orange County's System of Care
- vii. Joshua Bobko, Medical Director of Emergency Medical Services at the Orange County Fire Authority, as the At-Large Representative

On the motion of Commissioner Affable, seconded by Commissioner Morse, the Commission approved as recommended.
