
I write to request your support for the County of Orange's community project funding request of \$1 million in support of the Newport Beach Harbor Patrol Boat project. This project would allow for the purchase of two harbor patrol boats, enhancing public safety, security, and operational efficiency in one of Southern California's busiest harbors.

The Orange County Sheriff's Department Harbor Patrol Bureau is responsible for 24/7 maritime law enforcement, firefighting and emergency response, serving as emergency first responders in Orange County's harbors and coastline. Deputies respond to 12,000 calls for service annually. Many of the Sheriff's 16 boats are near (or in some cases have exceeded) their service life.

The proposed project allows the department to replace two aged vessels with new patrol boats, ensuring that Harbor Patrol can effectively respond to emergencies and conduct search and rescue missions in the harbor and coastal waters. Ultimately, the boats will provide safe and functional vehicles for Harbor Patrol personnel, ensuring they can effectively serve the community. As Newport Beach Harbor continues to expand as a hub for tourism, recreation, and commerce, the Harbor Patrol needs additional resources to support the increased maritime activity.
